Foreword

Letter from the EFPC Head of Executive Board

My esteemed colleagues,

You hold in your hands what is already the fourth annual report of the European Federation of Pharmacy Chains (EFPC), mapping the activities of the federation during 2022. That there is now a fourth annual report must also mean that the EFPC is already going into its fifth year; I believe this fact is by itself strong testimony of the federation's ability to justify its existence.

The time which has passed since the establishment of the EFPC has had an extremely positive influence on the atmosphere which permeates our encounters whenever representatives of our members meet. The collaborative spirit of good professional fellowship and personal friendship has left its mark in everything the federation does. Sadly, the passage of time always also inevitably means that there will be personnel changes. The importance of the EFPC's role was brought home by the Czech deputy minister of health, who participated himself at the conference and appeared as a presenter, when he pointed out that this conference was in fact the only event of its kind organized by pharmacy representatives at the time, i.e., during the Czech EU presidency.



EFPC organized unique gathering of pharmacists from European pharmacy chains in Prague

The beginning of June saw the official kick-off of the latest project by the European Federation of Pharmacy Chains (EFPC) for pharmacists from the various member states and various pharmacy chains, who are organized within their respective national associations. This project, which has been named the "European Academy of Chain Pharmacists", has become a unique platform for meetings among pharmacists who take an interest in topics related to the European market and wish to familiarize themselves with the different conditions under which the pharmacy sector operates in various jurisdictions across Europe. In its first year, the Academy convened in Prague in the Czech Republic; it was attended by 35 pharmacists representing 10 chains and 6 European countries. Barbora Přikrylová, a Czech pharmacist, acted as the host of the event.

> The European Academy of Chain Pharmacists offered the special opportunity of having an open discussion about the way in which the pharmacy business operates in various European countries – aimed this time not at chain managers but at the pharmacists themselves. They, as representatives of their country, familiarized their foreign counterparts with the legislation and rules affecting pharmacists in their home country, the services they offer and the mechanisms for the dispensation and distribution of pharmaceuticals. In this way, participants of the Academy found out about the inner workings of the pharmacy sector in Slovakia, Hungary, Romania, Poland, Serbia and, of course, the Czech Republic.

> The gathering of pharmacists was attended by Daniel Horák, chairman of the EFPC executive committee, who formally opened the Academy, welcomed all pharmacists in attendance, and thanked them for their participation. "It gives me great pleasure that the European Federation of Pharmacy Chains has been able this year to add this project, long in the making, to the portfolio of its activities. It is not too early to say that the Academy has fulfilled its chief purpose – forging a bond among active pharmacists from all countries. The rich discussions of everyone on the various topics are proof that we've sorely lacked this kind of project; we shall carry on and develop it further," said Daniel Horák, presenting the new EFPC project.




















"It was a very pleasant surprise for our foreign colleagues to learn about the breadth of services offered at Czech pharmacies; most questions that were asked did in fact concern these services. People were interested in the training received by pharmacists, in the premises on which such services are provided, and in whether there exist any restrictions due to government regulations. The biggest surprise for people was to learn that these services are not covered by insurance (as they would be, if administered by a medical doctor), but that we offer them for free or on a self-payer basis," explains Matěj Nižnik, an Academy participant.

"Through the comparison with other countries, I realized for myself the liberty which we as pharmacists enjoy here, and the variegated character of the services we provide – which is by no means a given fact in other countries in the same way it is here. Personally, I believe that Czech patients could no longer imagine their pharmacy without the current range of services," adds Nižnik, and mentions a number of examples: Rx reservations, the option to operate an online store, and the mail-order distribution of OTC products (which is outlawed in a number of countries).

He said he was impressed in turn by the presentation given by Polish pharmacists, who told the story of how they began to vaccinate clients against Covid-19 during the pandemic at pharmacies, and followed up by administering also flu shots.

"It was my immense pleasure to present to our colleagues the vaccination procedure at Polish pharmacies – since last year, this is a new, and at the same time the only, complementary service which we may offer to patients at pharmacies. I and my colleagues demonstrated the entire process by which we got into vaccinations - from legislative theory to preparation and roll-out. I also gave colleagues a few tips and tricks from my personal perspective, in the event that their national laws principally allow for vaccination by pharmacists," shared her impressions Anita Jeglińska, a Dr. Max pharmacist who became the firstever pharmacist in Poland to administer a vaccine.



The Czech Republic was represented by pharmacists from the Dr. Max and Benu chains who demonstrated the state of play in the Czech pharmacy sector and the way in which it operates. Their summary of the modus operandi of Czech pharmacies, and the wealth of services offered by them, triggered a lively Conversely, the Hungarian colleagues from Benu pharmacies reported how they reel under the ban of online store operations and of commercial activities by pharmacies of any kind. "For many of our colleagues, the Hungarian regulatory framework for pharmacies was a bit of a shock; aside from the demographic and geographic restrictions, they enquired about the regulation of pharmacy ownership, and in particular about the chief pharmacist's 51% ownership quota and veto right. This topic fielded the majority of questions," summarizes András Nagy. "We also presented how the work of pharmacists is being made more complicated by the restrictions on expanding the available range of goods at any given pharmacy, and the ban on loyalty programs, ostensibly designed to ensure that all patients are being served on equal terms," adds Zina Branyiczki, another Hungarian pharmacist.

The work of her Hungarian peers was admired by Zdenka Bobor Bartošová, a pharmacist from Slovakia whose presentation of the Slovak market caught the audience's interest when she described the voluntary membership of Slovak pharmacists in the professional chamber.

"Hungarian pharmacists have earned our unconditional respect for their poise in fighting government regulations and decrees such that they are still able to offer quality care to their patients. I feel similar admiration for our Serbian colleagues, who have been able to keep up functioning pharmacies in spite of extremely low regulated margins on medicinal products."

Low margins were also the topic of the representatives from Romania, who at the same time face the issue of an acute lack of graduates and active pharmacists. "We do have ten pharmaceutical faculties in Romania, but the number of students who graduate from them is smaller from year to year and

interest in the study program is continuously declining. This finds its expression in a shortage of staff in practice, and is leading to a stagnation of the pharmacy market in Romania, preventing us from offering supplementary services at pharmacies – we are simply unable to procure the workforce necessary to cover such services," described the problem Catalina Ilinca, a pharmacist from the HelpNet chain. The shortage of medical personnel was also the topic of a presentation by Tomáš Šebek, a Czech physician and proponent of telemedicine who showed how the problem may be resolved using modern technology. He also presented cutting-edge approaches to examining patients remotely with the aid of technology, the regulatory hurdles which stand in the way of further development of such modern approaches, but also the potential risks inherent in them. A discussion ensued during which a unanimous consensus emerged among the participants that the further growth of telemedicine is needed and important also from the point of view of pharmacies, provided that efforts are being made at the same time to educate patients.

In the light of the positive response by the participants and their express wishes, the representatives of the European Federation of Pharmacy Chains have already resolved to put the next few months to good use by planning the next meeting in the series for 2023, to be held in another member state.

Bulgaria – statement on restricting vertical integration in the pharmaceutical field

The European Federation of Pharmacy Chains (EFPC) hereby wishes to express its concern at the possible adoption of public policy measures aimed at restricting vertical integration in the pharmaceutical field in Bulgaria.

At the level of the European Community, there is a wide variety of regulations in this area. The existence of this diversity, in the daily practice of each state, allowed us to draw conclusions regarding the optimal models for ensuring the sustainable development of the pharmaceutical sector, for the ultimate benefit of the citizens.

EFPC is thus in a position to appreciate that a possible limitation of the vertical integration on the Bulgarian pharmaceutical market risks generating multiple negative effects, including long-term, for the future of the pharmaceutical sector in this market, as well as for the final consumers.

Such a regulation would call into question the sustainable development of community pharmacies as vertical integration helps to support the non-profit operation of medicines retail. The closure and/or absence of investments in the opening of new community pharmacies in rural regions will have a direct effect in reducing the population's access to medicines. There is also a significant risk for increases in medicine prices, given that vertical integration allows business efficiency, which ultimately is seen in strengthening competitiveness and discounts for consumers. Community pharmacies might concentrate only on medicines and less on ensuring extended services.

Vertical integration is also an engine of increasing competition in the field, stimulating not only the most competitive pricing policies, but also the provision of related services, which contribute to increasing the quality of general services offered by community pharmacies to the population. Thus, followup quality management systems are implemented (a permanent process of maintaining the quality of end-consumer-oriented services) and the highest levels of training of professionals in both downstream disciplines are ensured in an integrated manner.

In view of all these elements, the EFPC would like to warmly recommend to the decision-makers in Bulgaria the preservation of the current normative provisions regulating the activity of community pharmacies and which currently position this country as a model of good practices at European level.

3rd EFPC Conference "Pharmacy Care – What are the Barriers to Pharmacy Development?"

REPRESENTATIVES OF PHARMACY CHAINS CALLED ON THE EU CHIEF REPRESENTATIVE TO INVOLVE EUROPEAN PHARMACIES IN THE EU4HEALTH INITIATIVE

The European Federation of Pharmacy Chains organized its third international conference, this time in Warsaw. The conference was held under the title "Pharmacy Care - What are the Barriers to Pharmacy Development?" and was attended by pharmacists, politicians, health experts, representatives of pharmacy chains, deans of pharmaceutical faculties, as well as pharmacy students and representatives of patient associations. In three thematic panels, it was discussed, for example, how the COVID-19 pandemic manifested itself in the development of new pharmacy services or where outdated regulation stands in the way of this development. This also played a role in another of the topics: the promotion of the pharmacy assortment and services in connection with the self-medication by representatives of pharmacy chains to the main representatives of the European Union with an appeal for pharmacists to be fully counted among health professionals within the framework of the accepted European initiative EU4Health.

Warsaw, 19 October 2022 – The conference was a good opportunity not only to exchange views and experiences across the European region, but also to sign a joint call and request for the involvement of European pharmacies in the EU4Health initiative. It currently brings together all important stakeholders of the European healthcare sector. The call was addressed to the President of the European Commission Ursula von der Leyen and Stella Kyriakides, the European Commissioner for Health and Food Safety with an appeal to support the participation of representatives of European pharmacies in this important initiative.

"With the document we signed, we request the inclusion of pharmacists in the EU4Health initiative, which has a number of projects related to European health care, and we believe that pharmacists can also play an important role in some of them. The declaration was signed by representatives of all EFPC member states – Poland, the Czech Republic, Slovakia, Hungary, Romania and Serbia. In these, but also in many other countries, the pandemic has shown that pharmacists are an important primary contact for patients, and for this reason we want the pharmacy segment to be included in this initiative. We are ready to actively participate in the projects and help create an effective health care system for Europe, where we hope the pharmacy will play an important role," says Daniel Horák, Head of the EFPC Board.

The conference was attended by a number of speakers, including deputy health ministers from host Poland, as well as from the Czech Republic (currently EU presidency state). Czech Deputy Minister Jakub Dvořáček appreciated that this was an event organized by the pharmacists themselves. "This cannot be said about any of the other medical conferences that I have had the opportunity to visit, this event is the first of its kind," added Jakub Dvořáček.

The activity of pharmacists is bearing fruit, which can be seen, for example, in Poland, where the law allows vaccination in pharmacies as well as in surgeries. "The effectiveness of the vaccination program against COVID-19 and seasonal flu in Poland shows the great potential of pharmacies, especially chain pharmacies. But vaccination is only the first step. In Western Europe, the range of services that can be provided in pharmacies is much wider and can respond to other health challenges of the population, not only those related to infectious diseases, but also, for example, the no less serious civilizational disease epidemic," explained Marcin Piskorski, president of PharmaNET Pharmaceutical Employers' Association.

The fact that the introduction of such new services in pharmacies is a purely political decision was alleged during the conference by the lectures of not only Polish, but also British representatives, where vaccination in pharmacies, whether against flu or covid, was part of government policy, the strategy of the Ministry of Health and had considerable support insurance companies. "At the same time, for our network, we have not recorded any serious side effects of vaccination that would threaten the health or even the life of patients vaccinated in pharmacies," said Niral Dawda, head of retail strategy and transformation at Rowlands Pharmacy (UK), in his speech.

"The future of pharmacies is in the specializations that differentiate them from each other. Some will focus more on vaccinations, others on providing consultations, the most important part of which will certainly be prevention. I believe that preventive programs are effective tools to save significant amount of money for the health system and should be more perceived by politicians, insurance companies, but also by patients themselves. I also think that pharmacists should be more visible and should tell themselves how they want their profession to be in the future and how they want to specialize. Warsaw declaration is just one of the steps to include pharmacists in the system and remind them that pharmacies must be counted with in the future," added Daniel Horák.

During the conference, it was emphasized many times that, from the point of view of interest, pharmacies have enormous organizational, logistical and material potential and are an integral part of European health systems, which is proven by the existing services provided, but also only by the opening hours of pharmacies. Many offer 24/7 patient support across the European region.

"The importance of pharmacies for ensuring continuity of treatment and general health safety during the pandemic was considerable. It is worth reminding that the average time of a patient's visit to a pharmacy tripled in that time in Poland. When addressing the petition to the EU authorities, we tried to contribute to everything, how important pharmacies can be for the health of Europeans," concluded Marcin Piskorski.

The EFPC plans to hold its next conference in 2023 in Budapest.



















Joint statement on the need of inclusion of pharmacy sector into EU4Health Initiative

We, representatives of the European pharmaceutical chains associated under the EFPC call on the European institutions to include the European pharmacy sector in the EU4Health initiative. The sector has proven to be one of the key sectors in fighting the COVID-19 pandemic, offering patients testing, vaccination and first-contact advice – on time, close to patients' homes and without access problems.

In order to promote public health values across all Member States, the EU4Health should not forget about the great potential of pharmacies as an indispensable component of healthcare systems in Europe. We offer assistance and support to patients twenty-four hours a day, seven days a week. We are changing and growing rapidly, offering patients not only dispensing medicines, but also advanced new pharmacy services, such as education and health promotion, assistance in disease prevention and early diagnosis, support in addiction treatment, drug reviews, prevention of poly-pragmasy, learning to use medical equipment, and drug delivery. Additionaly, during last years European pharmacies has offered millions of doses of vaccines, not only against coronavirus, but also influenza and other deseases. This trend has been strong for years in Western European countries, and is now gaining strength also in Central European pharmacies, represented by members of our organization. The sector should be able to develop in all Member States, offering services that will ease the burden on national health systems.

We urge the EU4Health Initiative to consider all this, and in consequence to give European pharmacies their rightful place in this important initiative.

I am very attentive to stakeholders' views and we therefore organise consultations and dedicated events to gather their input on future needs and possible health priorities.

Executive Committee Meeting in Warsaw

18 January 2022 Executive Committee Meeting – online

The main focus was on the 3rd Annual Conference, which was going to be held in Warsaw, Poland. The Board members approved the proposal of the speakers and panels.

Priorities for 2022 were discussed, and a new project for pharmacists of pharmacy chains was introduced.

15 March 2022 Executive Committee Meeting – Online

EFPC Board members had an emergency meeting due to the current war situation in Ukraine, which had a huge impact on neighbouring countries, especially on Poland. Because Poland was handling a huge and unpredictable incoming wave of migrants, our Polish colleagues expressed their doubt about continuing with the organization of the conference. Their concerns included the safety of all attendees and considerations of moral principles. They highly recommended to postpone the conference until the following months.

Because the situation was not clear in East and Central European countries either, the Board members decided not to hold the conference and to postpone the date of the conference to June or to autumn. The conference was duly postponed from 29/30 March to 18/19 October 2022.

29 March 2022 Members' Meeting in Warsaw

Sebastian Ring resigned from the EFPC Executive Board in March, so the program of the membership meeting focused primarily on the election of a new member of the Executive Board. Nikolay Binev Kolev was nominated to the EFPC Executive Boards by the ADRFR. After the nomination speech, he was elected. Nikolay Binev Kolev became a member of the Executive Board of the EFPC on 29 march 2022.

During the meeting in Poland, the names of participants of the European Academy of Chain Pharmacists were announced, and a full agenda and program were introduced.

A discussion was held on the new legal changes in the pharmacy sector in Hungary, and it was presented by the Hungarian representatives.

7 June 2022 Members' Meeting in Prague

The June meeting had two parts: the Executive Committee meeting and the Membership meeting, when the financial statements for 2021 were approved.

During the Executive Committee meeting, the Annual Conference was discussed, and the speakers list was updated. Due to the high inflation that hit Europe, the budget of the conference had to be increased as well.

The issue of price increases in pharmacies was discussed in relation to inflation. Each member country shared its experience with political negotiations on increasing or changing pharmacy remuneration to be more in line with current energy prices and the situation on the pharmaceutical market.

18 October 2022 Members' Meeting in Prague in Warsaw

The last meeting of the year dealt with the Board members' election. During it, an election was planned to elect the current members of the Executive Committee in order to unify their election period. Karolina Korodi, Sína Niku, Marcin Piskorski, and Nikolay Binev Kolev were elected as Board members. Daniel Horák was elected as Chairman of the Board for the next 2 years.

Board members also voted for changes in the Articles. Approval was needed to change the current wording in the deletion of Article 5, paragraph 10 of the founding charter, so that it better corresponded to the current situation and practical experience. All re-elected members approved the amendment to the EFPC statutes.

The issue of the EU4Health Initiative was introduced, a communication strategy was discussed, and an engagement plan was proposed to all Board members. Zdeněk Blahuta, Executive Director, presented that letter to Stella Kyriakides, Member of the European Commission on Health and Food Safety. Ursula von der Leyen, the President of the European Commission, was briefed, and an official ceremony for signing the letter was prepared during the day of the conference.

Executive Director Letter

Dear readers, dear friends.

This time a year ago, we were all looking forward to the end of the pandemic and expecting a normal year again. With great eagerness, EFPC still embarked in the autumn of 2021 on the preparation of its traditional professional conference. This time, it was to be held in Warsaw to be even more representative. At the same time, we decided to try to establish an interactive platform for our pharmacists in the form of the 1st EFPC Academy, held in June 2022 in Prague.

But, unfortunately, everything changed on 24 February 2022, when the war in Ukraine started. A humanitarian crisis guickly emerged in the Central European countries facing a massive inflow of Ukrainian refugees (mainly women and children) and started to gain momentum. With less than a month to go before the Warsaw conference, we had to unexpectedly postpone it. We did this not only at the request of our Polish colleagues, but also at the request of the Polish authorities who were burdened with coping with the enormous influx of refugees and their subsequent socialization under new conditions. Fortunately, our conference did successfully take place in October 2022, as a breath of fresh air and normalcy in the first year of the war. We were all very pleased with the previously mentioned Academy of Pharmacists of our members in Prague last June. In my opinion and from the feedback of the participants, it was a very beneficial event with a huge impact on strengthening the sense of togetherness and the rightness of the path taken to the highest quality of care. In their feedback, the participants themselves praised us very much, but, most importantly, they asked us to continue the Academy in future years and to further develop it.

In last year's annual report, I referred to the team spirit and constructive atmosphere in the day-to-day activities of the EFPC. I believe that without such an approach we would not have managed the war's humanitarian crisis so well, and not only in Warsaw.

Among other EFPC actions, I would like to highlight our offer to the Croatian pharmacy network Ljekarna Pablo to become a member as a European economic entity. By the end of 2022, the offer had not yet been taken up.

As part of the exchange of the Romanian National Association ADRFR representative on the Executive Committee in spring 2022, contacts were also established with the upcoming Bulgarian Association of Pharmacy Chains. Next year, we will try to open negotiations for the Bulgarian association to join the EFPC.

Strengthening our presence in Brussels seems to be an important task ahead of the EFPC. In the meantime, we are starting to take advantage of the synergies and contacts of our Polish member ZPA PharmaNET, which is part of the Lewiatan association. Next year, we should present our projects to both the European Parliament and the European Commission.

Let me conclude by thanking all members and colleagues for their cooperation and commitment in 2022. Without them, our 2022 Annual Report would not be as diverse and colourful.

It represents over 35.700 pharmacy experts, 6.500 pharmacies and 6 European countries.

An important part of the EFPC activities is support and protection of the interest of its members, conduct and report of surveys work related issues. The EFPC was developed from a response to negative trends in some Central and Eastern European countries which are in conflict of patient interests.

Upcoming Events 2023

For the year 2023, the European Federation of Pharmacy Chains (EFPC) members have set several goals, namely to continue all the activities that they started in previous years and which are of increasing interest not only to members, but also to the professional public. One such activity is the already traditional annual EFPC conference, which will be held in Budapest in October 2023 and will be our 4th annual conference event.

In 2022, the European Academy of Chain Pharmacists pilot program was launched, which was aimed at employees and pharmacists working for pharmacy chains. The aim of the exchange program was to strengthen contacts and communication between pharmacists and to improve the knowledge of laws and regulations and their impact in individual countries. This project has proven to be a highly sought-after communication platform, especially in the post-COVID pandemic, when the pharmacy profession has faced major changes and has been under significant social and political pressures. EFPC members plan to develop and expand this project in the future, so that it is a useful platform for the discussion of pharmacy topics in Europe. The host country for 2023 will be Romania.

Another focus for EFPC members is membership. Our long-term priority is to increase the number of EFPC members, so that the federation is understood to be a true and equal partner in negotiations at the European level. Membership negotiations will take place with Croatian chains and the Association of Baltic States. Likewise, our goal is to start communication with Italian pharmacy chains and the representatives of Bulgarian chains as well.

EFPC members plan to join the EU4Health initiative and to be active in commenting on European legislation related to pharmacy issues, primary care, and prevention programs. To this end, a peer-reviewed seminar will take place in Brussels next May, which will be part of a series of Brussels activities culminating in a pan-European conference in 2024.

Last but not least, EFPC 2023 will continue to provide all support and cooperation to the Polish Association in dealing with EU infringement cases in Poland and will help the Hungarian Association to deal with the amendment banning online pharmacies and to reduce the risk of pressure to cancel the franchise in Hungary. It will also focus on supporting Bulgarian themes.
